
















# जागरूकता की कमी से पैर पसार रहा सर्वाइकल कैंसर : डा.सवेरा

गाजियाबाद : रोटरी हेल्थ अवेयरनेस मिशन, रोटरी क्लब ऑफ दिल्ली लिगेसी व इंदिरापुरम परिवार की ओर से नूर नगर स्थित परिवर्तन स्कूल में बृहस्पतिवार को सर्वाइकल कैंसर पर जागरूकता कार्यक्रम का आयोजन किया गया। इस दौरान दिल्ली के धर्मशिला नारायणा कैंसर सुपर स्पेशलिटी हॉस्पिटल की डा. सवेरा ने छात्राओं को सर्वाइकल कैंसर के बारे में जागरूक किया। डा.सवेरा व अन्य अध्यापिकाओं को शॉल ओढाकर सम्मानित भी किया गया। डा.सवेरा ने कार्यक्रम को संबोधित करते हुए कहा कि जागरूकता की कमी के कारण आज सर्वाइकल कैंसर पैर पसार रहा है। यह लाइलाज नहीं है। सर्वाइकल कैंसर दुनियाभर की महिलाओं में स्तन कैंसर के बाद होने वाला दूसरा सबसे आम कैंसर है। औसतन विश्व में हर 10 में से एक महिला (35 से 55 आयुवर्ग) इसका शिकार होती है। यह मुख्यत ह्युमन पेपिलोमा वायरस या एचपीवी के कारण होता है। यह ऐसी स्थिति है, जो मुख्यत गर्भाशय ग्रीवा यानी सर्विक्स की परत या गर्भाशय के निचले हिस्से को प्रभावित करती है। यह कैंसर धीरे-धीरे विकसित होता है और समय के साथ पूर्ण विकसित हो जाता है। देश के ग्रामीण इलाकों में जानकारी के अभाव में अधिकतर महिलाओं की मौत इससे ही होती है। लोक-लाजवश भी कई महिलाएं इस समस्या को दूसरे से कह नहीं पातीं। इसी का नतीजा है कि विश्व के बाकी देशों के मुकाबले भारत में सर्वाइकल कैंसर तेजी से अपने पैर पसार रहा है। महिलाओं





को संक्रमण से बचने के लिए जीवनशैली में परिवर्तन करने चाहिए। इसमें कई साथियों के साथ यौन संपर्क से बचाव, नियमित जांच, धूम्रपान का त्याग, फलों, सब्जियों व साबूत अनाज का सेवन और शरीर का वजन ठीक रखना प्रमुख कदम हैं। रोटरी हेल्थ अवेयरनेस मिशन के चेयर डा.धीरज भार्गव ने कहा कि

सर्वाइकल कैंसर का इलाज उस स्टेज पर निर्भर करता है, जिस स्थिति में कैंसर का पता चलता है। आमतौर पर शुरुआती अवस्था में सर्जरी द्वारा गर्भाशय को निकाल दिया जाता है। लोगों में आम ध गरणा है कि अगर उनके परिवार में यह पहले किसी को नहीं हुआ, तो उन्हें भी नहीं होगा। लेकिन सच यह है कि इसके बावजूद

# Substantive equality: on SC/ST govt. staff promotions

The Supreme Court verdict upholding a Karnataka law to preserve the consequential seniority of Scheduled Caste/Scheduled Tribe candidates promoted on the basis of reservation is notable for being the first instance of quantifiable data being used to justify reservation. After a similar 2002 law was struck down on the ground that there was no data, as required by the judgment in Nagaraj (2006), the Karnataka government appointed a committee to collect data on the "backwardness" of SC/ST communities, the inadequacy of their representation in the services and the overall impact of reservation on the efficiency of the administration — parameters laid down in the 2006 verdict as constitutional limitations on the power to extend reservation in employment. Based on the report, the State enacted a fresh law, which has now been upheld on the ground that it is compliant with the Nagaraj formulation, as well as the clarification found in Jarnail Singh (2018). A key principle in this decision is that where reservation for SC/ST candidates is concerned, there is no need to demonstrate the 'backwardness' of the community. The other pre-requisites of a valid system — quantifiable data on the 'inadequacy of representation' for classes of people identified for reservation, and an assessment of the impact of such quota on the "efficiency of administration" — remain valid. Justice D.Y. Chandrachud's judgment applies the rule emerging from Jarnail Singh, which decided that Nagaraj did not require reconsideration. At the same time, it held that Nagaraj was not right in insisting on data to justify the 'backwardness' of SC/ ST communities, as it contradicted a nine-judge Bench decision in Indra Sawhney (1992).

The judgment places in perspective the historical and social justification for according reservation, rejecting the argument that quotas, by themselves, affect administrative "efficiency". It says merit lies not only in performance but also in achieving goals such as promotion of equality, and that India's transformative Constitution envisages not just a formal equality of opportunity but the achievement of substantive equality. It accepts the subjective satisfaction of the government in deciding the adequacy of representation, subject to the norm that there should be relevant material before it. One must also recognise the constant tension between legislative intent and judicial interpretation. Most judgments on affirmative action indicate that the courts are laying down constitutional limitations, lest the equality norm, a basic feature of the Constitution, be given the go-by. It is welcome that the backwardness of the SCs and STs no more needs to be demonstrated. Policy-makers should heed the appeal contained in the judgment: there is no antithesis between the concept of efficiency and the inclusion of diverse sections of society in the administration. While data on representation may be a requirement, the idea that reservation has an adverse effect on administration must be rejected.

### Will adjust excess fee next year, school tells parent

NOIDA: The Cambridge School in Noida Sector 27 has informed a single parent of a nursery student that Rs 18,835 charged by it will be adjusted in the next quarter. The move came following a notice from the District Fee Regulation Committee (DFRC), which had asked the school to refund all fee charged in excess of what was permissible under Uttar Pradesh Independent and Self-funded Fee Regulation Act (2018). The parents' group, which had filed the complaint with the DFRC, said that a single

resolution is not what they expected from the school. "The school has responded to one complaint, but it must refund the excess fee of all students even if only one parent had filed the complaint," said K Arunachalam, the general secretary of All Noida School Parents' Association (ANSPA). No official from Cambridge School could be reached for a comment despite repeated attempts. The DFRC had sent the notice of refund on April 20 to Cambridge and Apeejay

schools in Noida. However, both the schools have been slow in acting on the refund order. "The schools are toying with the refund order. While the excess fee has been refunded to some parents in Apeejay, many are still waiting for the same. At Cambridge too, only one refund has been put through," Arunachalam added. Commenting on the delay in refund by the schools, the education department officials said that the unresolved refunds would be taken up for discussion in the next meeting of the DFRC.

# Asked not to drink, man fires at dad, kills self

**GREATER NOIDA:** Angry over being rebuked for consuming alcohol and reaching home late, a 35-yearold man allegedly fired at his father and then shot himself dead on Thursday night. The incident took place at Dalelgarh village in Dankaur. The father-son duo were taken to the district hospital where Bhim Singh was pronounced dead. His father, Rajvir Singh (62), is stated to be in a critical condition. Bhim used to stay with his parents. His elder brother lives in a separate house in the same locality. Bhim was reportedly an

#### Two can't pronounce Arabic words, beaten with belt

NOIDA: A teacher in a madrassa in Sector 115 has been booked for allegedly thrashing two minor sisters with a belt because they couldn't pronounce some Arabic words properly. A noncognisable report has been filed against the teacher on a complaint by the girls' father. The teacher is absconding. The teacher has been identified as Mohammad Nawab (45). The two students five and six years old are residents of Sector 73 and their father works as an Uber driver. The alleged beating came to light on May 5 when the parents of the two girls found injury marks on the back of their younger child.

alcoholic and due to that, his family members criticised him often, police said. On Thursday, around 9.30pm, Bhim allegedly reached home in an inebriated state. He was out all day and his father allegedly rebuked him for that. It soon turned into an argument and Bhim lost his cool. He allegedly fired at his father and then shot himself. #### Noida, Delhi spar over waste dumped in Shahdara drain

**NOIDA:** Sewage waste dumped by nearly 6,000 shanties into Shahdara drain has become a bone of contention between Noida Authority and the Delhi government's irrigation and flood control department (IFCD). "We cannot construct a sewage line as we do not have jurisdiction over the drain, which comes under IFCD. Manish Agarwal, executive engineer, IFCD, said the shanties are unauthorised. Agarwal said if the matter was taken to senior officials from both the governments for redressal, a viable solution can be arrived at.

# Madrassa teacher who thrashed minor girl with belt arrested

**NOIDA**: A religious teacher, who was booked for allegedly thrashing a six-year-old girl with a belt at a madrassa here for not being able to learn her lessons, was arrested on Friday, police said. A complaint was lodged at the sector 49 police station here against maulvi Mohammad Nawaz by the minor girl's father a couple of days ago, they said. "Nawaz, who taught at the madrassa in Sector 115, had gone absconding since police began the probe. He had come to the madrassa this afternoon where we nabbed him after a tip-off," SHO Ajay Aggarwal said. "The teacher told police that he has always been careful while

dealing with the students but the child seemed not to be learning her lessons and that irked him to the extent that he thrashed her with a belt," he said. Aggarwal told PTI said the teacher has admitted that it was a "mistake" and was apologetic about the incident. According to the girl's father, he had recently visited his daughter at the madrassa when he found that she had bruises on her back. "She told me that she was brutally beaten by the maulvi," he alleged. He further claimed that on enquiring about the matter at the madrassa, he was "threatened by around 10 people who had sticks in their hands".

# Bike tyre bursts, man dies after hitting divider

GHAZIABAD: A 25-yearold man was killed and another injured after one of the tyres of their motorcycle burst and the bike crashed into a divider on the Delhi-Meerut Expressway in Muradnagar area early on Thursday. Police said the victims were on a road trip to Haridwar along with two other friends when the accident happened. The deceased has been identified as Neeraj while the youth riding pillion with him is Amit (24). Neeraj worked as a wedding photographer while

Amit is employed with a factory in Delhi. Umesh Bahadur Singh, the SHO of Muradnagar police station, said the accident occurred around 1.30am on Wednesday and police were informed half an hour later. "The two men on another bike took Neeraj and Amit to a private hospital. Neeraj was declared dead on arrival. Initial investigation has revealed that they were drunk," he said. Neeraj, according to the police, was not wearing a helmet.

## Domestic help falls off 14th-floor flat, dies

GHAZIABAD: A 19-yearold woman died allegedly after falling from a 14th floor flat of a highrise in Vasundhara on Saturday night. Meenakshi, who worked as a domestic help in the flat at Olive County in Sector 5, was rushed to a nearby hospital, where doctors declared her dead. Police suspect she committed suicide. Sandeep Kumar Singh, SHO, Indirapuram police station, said the tragedy happened between 8.30pm and 9pm. "The flat belongs to VK Sondhi and his wife, both of whom were outside at the

## Six held in Tronica City after gunfight

GHAZIABAD: Six men were arrested for their alleged involvement in a gunfight with police in Tronica City on Tuesday. The six were identified Ravi Dutta from Delhi, Shahnawaz from Meerut, Jaan Muhammad from Muzaffarnagar, and Nijam Khatri, Rajender and Arshat from Tronica City. SP (rural) Neeraj Kumar Jadaun told TBC that the gunfight took place 200 metres from Tronica City police station during a routine check. "The gunfight took place when

the accused, who were coming in two cars, were stopped for checking. They then opened fire at the police officers. There were 10 rounds of firing from both sides before the police overpowered them," the officer said. Coming from Delhi, they were headed to Ghaziabad to allegedly commit some crime. "During the gunfight, a police bullet hit Ravi, the kingpin of the gang. In 2014, he killed a rival gang member Suresh alias Bura outside Surajpur court," he added.

## One held for stealing ATM cash

**GHAZIABAD:** A 30-yearold man was arrested in connection with a bank fraud of Rs 72 lakh from Link road on Thursday. According to police, the accused, identified as Dilip Kumar Mishra, a resident of Delhi's Uttam Nagar, works as an associate with a cash custodian of a logistic company who used to fill cash in ATMs of various banks along with two gunmen in the city. "In April 2019, Dilip and his accomplice had defrauded banks with Rs 72.58 lakh by stealing some part of the cash which was to be filled in the ATM," a police officer said.

### Residents seek builders' corpus to finish flats

**GHAZIABAD:** The Federation of Apartment Owners' Association (FEDAOA) in the city has written to the Centre, suggesting that a clause be inserted in the Rera Act making it mandatory for builders to create a corpus that can be used to complete a stalled project. The forum suggested that builders be mandatorily asked to contribute a portion of the money earned from selling flats towards the corpus. "There have been a number of instances where builders have defaulted or have been declared absconders after leaving a project in a limbo. It

is the buyer alone who eventually bears the brunt," said Alok Kumar, president of FEDAOA. "There is a provision in the RERA Act. Under Section 75 (1) of the Act, a real estate regulatory fund can be created for a project. The money could later be used in completing abandoned projects. This will provide relief to distraught buyers. But the fact remains that this is still not in practice. It is against this backdrop that we have written to the ministry of housing and urban affairs to implement the order," Kumar said. The move comes a day after the UP-Rera bench in neighbouring Gautam Budh Nagar has planned to adopt abandoned projects in the district. In Ghaziabad, there are over 1,100 flats across several projects that have been left midway by the builder. Kumar said one of the viable options of addressing the problem was to create a real estate regulatory fund. He suggested that a portion of a transaction between a buyer and a builder be contributed towards the corpus. "Some part of a transaction, say between 0.5% and 1%, of the real estate property could be charged as contribution towards the corpus," Kumar said.

## 2 held for highrise burglaries

GHAZIABAD: Two men from Bihar were arrested on Wednesday for committing a series of burglaries in different parts of the city. The stolen goods have been recovered and they are worth several lakhs. Police said the accused had perfected the art of committing property offences to the extent that it barely took them 30 minutes to break into a house and flee with the valuables. The duo have been identified as Abid and Faizal alias Rahul. They had been living in Bhowapur village of Indirapuram for the past few days.

#### Two hired for doctor's murder arrested

GHAZIABAD: Two men were arrested from near Hindon Barrage on Tuesday around 1am for their alleged involvement in the murder of a 42-year-old ayurvedic doctor in February this year and a robbery which took place in a jewellery shop last week. With the arrest of Rohit (24), a resident of Burari in Delhi and Rakesh Dujana (28) from Gautam Budh Nagar, police claimed to have solved both the cases. According to police, both the men worked as 'hired assassins' and have several cases of murder and attempt to murder registere against them in NCR. On February 20, the ayurvedic doctor and

Bahujan Samaj Party (BSP) functionary Veer Singh was shot dead. SP (city) Shlok Kumar said, "The duo had been hired by two brothers, Sandeep and Pradeep, who lived opposite to Veer Singh in Rishi market. The brothers had several tiffs with Singh over petty issues in the past and they had a grudge against him." The SP added that soon after the attack their third accomplice Sanju was caught, however Rohit and Rakesh managed to escape. While they were hiding from the police, they needed money so on May 2 they robbed a jewellery shop in Vijay Nagar of ornaments worth Rs 4 lakh.

# Grandmother's revolver goes off, bullet hits boy

GREATER NOIDA: A seven-year-old boy was hit by a bullet allegedly after a revolver fell off his grandmother's hand during a family function in Greater's Noida's Badalpur and accidentally went off. The Class II student, Yash Sharma, was rushed to a private hospital in Vaishali, where doctors are trying to extract the bullet lodged in his stomach. Police said the revolver that went off is lodged in the 55-year-old woman's name. The cops are waiting for the family to file a complaint.

# Now, board a bus from metro station parking lot

**NOIDA**: The Authority and traffic police started parking of buses in the multilevel parking lot at Botanical Garden metro station on Saturday in an attempt to decongest the area. The buses are being parked in the space between the metro station and the upcoming multilevel parking lot. Now, buses are stopping at gate 4 of the metro station for a maximum of 15 minutes. On Saturday, a jersey barrier was placed on the road to direct buses towards the parking lot. Noida Authority did not charge parking fee on the first day and

sources said around 100 buses used the parking space throughout the day. "Buses were parked smoothly and there was no resistance from drivers, as they had been informed before hand. Buses can be parked for free for the first 15 minutes. We are working out what to charge in case they are parked for longer duration," said Rajeev Tyagi, the general manager, Noida Authority. Earlier, the entry and turning area for buses at the parking lot were checked and the space was modified to accommodate the vehicles.



### Noida Extension residents take stains off 15 statues in city

GREATER NOIDA: A group of 30 residents of Noida Extension cleaned around 15 statues installed by the Greater Noida Industrial Development Authority (GNIDA) with the help of water tankers, hosepipes and rags on Sunday. The group of residents said the statues had become an "eyesore" as they had been covered in dust for several months. The group began cleaning the statues at 6am on Sunday and worked till the afternoon. "We've already

completed cleaning an entire stretch of road in four weeks. Now, we've started cleaning the statues because they serve as landmarks for our addresses and are never cleaned. We decided to take up the responsibility and cleaned 15 of them today," Abhishek Kumar, president of Noida Extension Flat Owners' Welfare Association (Nefowa), said. Statues that have been cleaned include the Char Murti — the four statues of the Buddha at Kishan Chowk — and various animal figurines at several traffic intersections in the area. The residents mounted the statues and dusted them before washing them down with hosepipes. "We are proud to have contributed to cleaning the statues today. Mostly made of bronze, they have a lot of visual appeal, but remain shrouded in thick layers of dust. We will visit the statues again after some time. We have volunteered to clean up Noida Extension on our own because we live here and we don't get efficient

responses from the authorities on our complaints," Kumar said. Meanwhile, GNIDA officials said they have started repairing roads in the area. "It is good that residents are coming forward to clean their city. However, we have started working on the road repairs and other complaints they have brought to us," an official said. Residents of Noida Extension residents have, since April, come together to clean one of the area's major arterial roads in Sector 16B.

# Woman delivers stillborn, doctor booked for negligence

GREATER NOIDA: A Greater Noida-based couple has lodged a complaint at Sector 49 police station, alleging that negligence of a doctor of Cloudnine Hospital had led the woman to deliver a stillborn on March 9, The couple has alleged that Dr. Pratibha Singhal, who was supposed to do the delivery, arrived late by over 2 hours, in turn delaying the surgery. They also lodged a complaint with the National Commission for Protection of Child Rights (NCPCR) on April 4, after which it sought a report from the district magistrate in seven days. According to the commission, the DM was

supposed to give a report by May 9, but there has been no response yet. Ankit had complained that his wife had crossed her due date but there was no doctor available at the hospital. "Around 9.30 pm, Shweta's labour pain started. I immediately called the doctor who had been treating my wife. She said everything was normal. However, I had requested her to come to the hospital," Ankit told TBC. He added, "When we reached the hospital, a junior doctor examined her and at 10.15 am she said both the mother and the baby were fine and asked us to wait for the doctor."

# Noida to treat waste water, supply it to flats

**NOIDA:** The Noida Authority on Sunday set a target of recycling 100% of the water generated from its sewage treatment plant (STP) to make Noida a zerodischarge city. The initiative comes after Noida had kicked off a campaign on April 16 to treat horticulture waste through indigenous organic compost pits across the city's parks and green belts. As part of the plan, the STP in Sector 168, which has 50 million litres per day (MLD) water capacity, will be scaled up to 100 MLD by May 15 so as to make it fully functional and cater to the

increasing number of upcoming highrise apartments and green stretches. While Authority officials visited the site on Sunday, they maintained that laying of pipes has been completed at the plant from where treated water will be used to irrigate green areas and parks of the neighbouring sectors 91, 93, 137, 143, 143A and Faridabad-Noida-Ghaziabad green belt. The connectivity of pipelines has been completed in these areas and the process will begin by May 15," said Rajeev Tyagi, general manager, Noida Authority.

### Buses can't stop outside Botanical Garden station

**NOIDA**: In an attempt to decongest the main road in front of Botanical Garden metro station, the temporary bus stop on the road will now be shifted to the newly built multi-level car parking space. From Saturday, buses will pick up passengers from the parking area and use gates 1 and 4 of the metro station to enter and exit the main road. "The diversion has been planned to decongest the main road near the metro station. From Saturday, all buses, including DTC buses, will move from inside the station road. Some buses will be given space to pick up passengers from inside the parking area," said Anil Kumar Jha.

# Two men push sister out of car, throw acid at her

**GREATER NOIDA:** A 22year-old woman was allegedly attacked with acid by her two brothers who later dumped her in Kot village in Greater Noida's Dadri on Thursday afternoon. The survivor is currently admitted to Delhi's Safdarjung Hospital with burn injuries on the face and neck and is in critical condition. According to police, the woman belongs to Gulawati village in Bulandshahr district of Uttar Pradesh and lives with her parents and two brothers. Neeraj Malik, the SHO of Dadri police station, said the woman, in her primary statement, had alleged that her two brothers had taken her on

a drive on Thursday noon from their village to Noida city. "Midway, the accused brothers pushed her out of the car and threw acid on her face," added Malik. The matter came to light when a passerby alerted police after seeing the woman lying unconscious on the road with her face burnt. "We received information at 2.35pm from a passerby who spotted the woman. A police team immediately reached the spot and the woman was rushed to the district hospital in Noida from where the doctors referred her to Safdarjung Hospital," said Malik. Police are trying to track the two youths.

#### Missing youth from Dahisar found in Noida

**MUMBAI:** A 20-year-old Dahisar resident, Parshva Vira, who had been missing since Saturday was found in Noida on Wednesday. He had gone to Delhi for a job interview without informing his family, said Vasant Pingle, senior inspector at Dahisar (E) Police station. On Saturday afternoon, Vira had left for his uncle's place in Ghatkopar but never reached. Unable to contact him, his family filed a missing complaint. Vira had sold his phone at a Borivli mall to buy new one, and used the money to buy a ticket to Delhi, said police.

# Two in blue Baleno attack man, snatch his gold chain

Noida: Two men in a blue Baleno car allegedly assaulted and snatched a lawyer's gold chain on Sunday near Prateek Wisteria Society in Noida Sector 77. The victim, identified as Mohit Arora, was rushed to Neo Hospital with a injury to his nose. Arora, who is in his thirties, lives in a flat in Civitech Sampriti Society. He is a company secretary at a Noida-based private firm. On Sunday, around 1.45pm, Arora was standing on the main road leading to the metro station road in Sector 77 when the two men accosted him and asked for directions to a

place. They then attacked him with the butt of the pistol, he said in a police complaint. "I went out to get a chain in my office bag repaired. The shop is at the corner of the main road in front of Prateek Wisteria. The accused approached me in a blue Baleno. As I went closer, one of them pulled out a gun and threatened me. They even attacked me. I called out for help, but the men snatched my gold chain and fled away," the victim told TBC. Ajay Aggarwal, SHO of Sector 49 police station, said that the victim had verbally informed them about the crime.

#### Extortion row: Scribes did sting on others too

**GREATER NOIDA:** Two reporters accused of trying to extort Rs 2 crore from Union minister Mahesh Sharma had conducted sting operations on other influential people in the past, police have learnt. Alok Kumar, the owner of a nowdefunct news channel Pratinidhi who had conducted the alleged sting on Sharma, and his colleague Nishu were remanded in police custody again on Saturday. Police are now trying to trace another one of his accomplice, Khaled.

#### Out for walk, man mowed down by truck on Eastern Peripheral Expressway

**GREATER NOIDA:** A 35year-old man was mowed down by a speeding truck on the Eastern Peripheral Expressway in Dankaur on Sunday morning. The victim has been identified as Satyendra Kumar, who was a hardware store owner in Imliya village. Police said the accident occurred in the early hours of Sunday when the victim, Satyendra, was out on a morning walk on the Eastern Peripheral Expressway. When he tried to cross the road, a speeding mini truck hit him and he collapsed on the spot, the cops said. "The bystanders,

who witnessed the accident, dialled the emergency number 100 to inform us. A police team immediately reached the spot. The victim had died soon after the accident and the truck driver fled, leaving his vehicle behind," said Samresh Kumar Singh, station house officer (SHO) at Dankaur police station. Later, the victims' family members and some locals started protesting on the expressway. They demanded strict action against the accused truck driver. After the traffic on the expressway came to a standstill, the police assured the protesters of an inquiry into the matter.

## Three held for cattle theft, selling beef

NOIDA: Three men, accused of stealing cattle and selling beef were arrested early on Saturday from Sector 8. Each of them had a reward of Rs 25,000 on their arrest. The arrested accused have been identified as Aarif (42) and Kasim (40), who are brothers and residents of Khurja in Bulandshahr, respectively. Their third brother, Rizwan, managed to escape. Apart from the brothers, a 38-year-old man, Yaseen, was arrested. He, too, is from Bulandshahr. "While Arif is named in around 50 cases, Kasim is named in 23 and Yaseen has five cases registered against him at various police stations of Bulandshahr.

#### Noida cracks down on buses picking up passengers on expressway

**NOIDA**: Following several complaints from residents regarding congestion caused by private buses under Mahamaya flyover along the Noida-Greater Noida Expressway, the district administration has finally cracked down on the vehicle operators. Over the past 10 days, officials said, the Gautam Budh Nagar administration has detained about 35 drivers, conductors and other staffers under Section 151 of CrPC and filed 12 complaints against private bus operators for cheating and disobedience to order duly promulgated by a public servant. Another 125 operators have been asked to

submit an affidavit that their buses will not stop on the expressway. "The sanctity of the expressway as a highspeed corridor has to be maintained and we cannot allow such miscreants to create traffic chaos and dangerous condition for other vehicles using this stretch. We've started taking action against these buses and will continue the drive," said BN Singh, district magistrate of Gautam Budh Nagar. Residents said the turn near Mahamaya flyover has become an unofficial parking spot for buses that pick up and drop passengers there, making it dangerous for other

speeding vehicles. "It had become a daily nightmare for us as the buses would stop along the expressway, blocking the entire road. They would also have their engines running for about half an hour, adding to pollution. It was a huge problem, especially for residents of Sector 44 as our entry gate and the road leading to it was blocked," said Sudhir Sood, general secretary of Sector 44 RWA. However, the problem of buses stopping along the expressway is not restricted to just traffic jams. It is much deeper and pertains to catering to the public transport demand in the city.

## SC: Afraid of what you will do with property?

**NEW DELHI:** After Noida and Greater Noida authorities said they won't be able to complete Amrapali projects, the Supreme Court said it would pass orders on handing over the projects to other companies and would consider the option of government-owned NBCC, Hudco or reputed private companies like Larsen & Toubro. "So you are afraid of what you will do with the property," the bench of Justices Arun Mishra and UULalit said. The court directed the authorities to issue occupation certificates in those projects in which people had taken possession of flats to enable them to live there.

## Bird risk to flights puts question mark over wetlands around Jewar

**NOIDA:** The fate of 63 wetlands hangs in balance as they lie within the area earmarked for Jewar airport and in the adjoining 15 km. Responding to an RTI query, the forest department has said there are three wetlands over 2.5 hectares in the area that lie within the Jewar airport land. Another 60 wetlands are within the adjoining 15 km, making it a total of 63 in the proposed airport's impact zone that cannot be provided protection. Wetlands are breeding grounds for birds and their presence around the path of flights increases risk of bird strikes to planes. According to

the draft Environmental Impact Assessment (EIA) report prepared earlier for the Jewar airport, the area is also close to the sarus crane habitats and their presence can impact flight safety. Officials, however, say since the planning for the Jewar airport is still in its nascent stage, these wetlands will be looked into and their management plan will be prepared. But environmental activists have made it clear that scientific alternatives are required to compensate for these wetlands since Jewar's water table is already over exploited.

## 22-year-old attacked with acid critical

**NEW DELHI**: The condition of the 22-year-old woman, who was allegedly attacked with acid by her two brothers and later dumped in Kot village in Greater Noida's Dadri, is serious. She has received burns in the face and neck region, doctors at Safdarjung hospital said. There was no one from the family at the hospital. Police said the woman belongs to Gulawati village in Bulandshahr district of UP and lives with her parents. Neeraj Malik, SHO, Dadri police station, said the woman in her primary statement had alleged that her two brothers had taken her on a drive on Thursday noon from their village to Noida.

## Unsegregated waste won't be collected from July, Noida tells malls and hospitals

NOIDA: The Noida Authority has written to all institutions in the city, including RWAs, malls and hospitals, to start segregation of waste before June 30 and make arrangements for composting of wet waste. After June 30, officials said, the authority contractors will not pick up unsegregated waste from any locality or industrial area. This is being done to ensure minimum waste reaches the landfill. The city generates nearly 1,000 tonnes of municipal solid waste daily. "Once the waste is segregated at source, the wet waste can easily be

turned into compost. We can ensure that only dry waste is taken to the dumping site. This is why we have started sending out letters to all institutions for awareness so that they initiate segregation within their areas," said SC Mishra, deputy general manager, Noida Authority. There are over 600 institutions, including RWAs, hotels, malls, industries, hospitals and factories, which will have to start complete segregation by June-end. The RWAs will also have to ensure that the wet waste can be locally turned into compost within their sectors.

### रिश्वत मांगने के आरोप में महिला थाने की दरोगा निलंबित

गाजियाबाद : मुकदमे की धमकी देकर वसूली करने वाले दरोगा व सिपाही के खिलाफ मुकदमा दर्ज कराने के बाद एसएसपी एक और दरोगा को निलंबित कर दिया है। इस बार महिला थाने की दरोगा पर रिश्वत मांगने का आरोप लगा था। संदिग्ध हालात में महिला के नींद की गोलियां खाने के मामले में आरोपित पति से रिश्वत मांगने के आरोप में महिला थाने में तैनात दरोगा प्रीति गर्ग को निलंबित कर दिया गया है। आरोप था कि धारा हटाने के नाम पर दरोगा एक लाख रुपये की मांग कर रही थीं। मामले में पीडिघ्त की शिकायत के आधार पर एसएसपी ने सोमवार शाम आरोपित दरोगा को सस्पेंड कर दिया। मुजफ्फरनगर के नई

मंडी में रहने वाले अनुज शर्मा का पत्नी सोनिया से विवाद चल रहा है। सोनिया मोदीनगर स्थित अपने मायके में रह रही है। अनुज ने बताया कि एक साल पूर्व सोनिया ने नींद की गोलियां खा ली थीं। गंभीर हालत में उसे अस्पताल में भर्ती कराया गया था। इस मामले में मायका पक्ष ने अनुज व उसके परिजनों के खिलाफ मुकदमा दर्ज कराया था। बाद में मामला महिला थाने में ट्रांसफर हुआ। दो माह पूर्व महिला थाने में तैनात दरोगा प्रीति गर्ग को उनके मामले की विवेचना सोंपी गई। आरोप है कि प्रीति गर्ग ने उन्हें जांच के नाम पर बुलाया। वह महिला थाने पहुंचे तो कहा कि मुकदमे में से धारा 328 को हटाई जा सकती है।

अनुज ने पूछा कि इसके लिए क्या करना होगा तो दरोगा ने कहा कि खर्चा होगा इसमें। रकम के बारे में पूछने पर उन्होंने एक कागज पर ही लिख दिया कि एक लाख रुपये लगेंगे। अनुज के मुताबिक वह निजी कंपनी में छोटी जॉब करते हैं और इतने रुपये का इंतजाम नहीं कर सकते। इसीलिए उन्होंने दरोगा को जवाब नहीं दिया। आरोप है कि प्रीति उन्हें अक्सर फोन कर जेल भेजने का डर दिखाने लगीं। कभी रात के 10 बजे तो कभी 11 बजे। बचने के लिए अनुज ने आने में असमर्थता जताई तो ख्द मुजफ्फरनगर आने की बात कही। आरोप है कि दरोगा ने बहन, जीजा, मम्मी व पापा को भी जेल भेजने की धमकी दी।
