दिल्ली के अस्पतालों में बढ़ेंगे 13 हजार बेड, बनेंगे 4 नए अस्पताल

नई दिल्ली : केजरीवाल सरकार दिल्ली के सरकारी अस्पतालों में बेड की क्षमता 120 फीसदी बढ़ाने जा रही है। अभी दिल्ली सरकार के 38 अस्पतालों में कुल 11,353 बेड उपलब्ध हैं। इन अस्पतालों में 13,899 बेड बढ़ाने की तैयारी है। दिल्लीवालों को अगले छह महीनों में तीन नए अस्पताल भी मिलेंगे, जिसके जरिए 2800 बेड बढ़ेंगे। द्वारका में पश्चिमी दिल्ली का सबसे बड़ा अस्पताल होगा। यहां नए इंदिरा गांधी अस्पताल की क्षमता 1241 बेड है। इसके अलावा 772 व 600 बेड की क्षमता वाले दो अस्पताल बुराड़ी और अंबेडकर नगर में जल्द बनकर तैयार होने वाले हैं। वहीं दिल्ली के मोहल्ला क्लीनिक में बेहतर स्वास्थ्य सेवाएं देने के लिए फार्मासिस्ट की तैनाती होगी।

प्लास्टिक की बोतल नष्ट करने पर यात्रियों के मोबाइल फोन रिचार्ज करेगा रेलवे

नई दिल्ली : एक बार इस्तेमाल होने वाली प्लास्टिक का प्रयोग बंद करने संबंधी पीएम नरेंद्र मोदी की पहल को आगे बढ़ाते हुए भारतीय रेलवे ऐसे यात्रियों के फोन को रिचार्ज करेगा, जो स्टेशनों पर प्लास्टिक बोतल नष्ट करने वाली मशीनों का इस्तेमाल करेंगे। रेलवे बोर्ड के अध्यक्ष वी.के. यादव ने कहा है कि स्टेशनों पर बोतलों को नष्ट करने वाली 400 मशीनें लगाई जाएंगी। इसका इस्तेमाल करने वाले यात्रियों को मशीन में अपना मोबाइल नंबर दर्ज करना होगा और इसके बाद उनका मोबाइल फोन रिचार्ज हो जाएगा।

## वाहन चेकिंग में मौत पर पुलिसवालों के खिलाफ किया गया केस दर्ज

गाजियाबाद : एनएच-9 के पास वाहन चेकिंग के दौरान रविवार को एक युवक की मौत हो गई थी। इस मामले में मंगलवार को अज्ञात पुलिसकर्मियों के खिलाफ गैर इरादतन हत्या का मुकदमा दर्ज कर लिया गया। गाजियाबाद के एसएसपी ने एसपी ट्रैफिक को जांच सौंपकर रिपोर्ट मांगी है। नोएडा सेक्टर-52 स्थित शताब्दी विहार निवासी गौरव एक सॉफ्टवेयर कंपनी में काम करते थे। रविवार को वह माता-पिता को लेकर कार से जा रहे थे। एनएच-9 के पास वाहन चेकिंग के दौरान पुलिसकर्मियों ने उनकी कार पर डंडा मारा। गौरव ने विरोध जताया तो पुलिसकर्मियों से नोकझोंक हो गई। इसी दौरान

दिल का दौरा पड़ने से उनकी मौत हो गई। उनके जमीन पर गिरते ही पुलिसवाले मौके से खिसक गए। सोमवार को सोशल मीडिया पर मामले ने तूल पकड़ लिया। इसके बाद मंगलवार शाम गौरव के पिता मूलचन्द्र शर्मा ने इंदिरापुरम थाने में लिखित शिकायत दर्ज कराई। एसएचओ इंदिरापुरम ने बताया कि परिजनों की शिकायत पर अज्ञात ट्रैफिक पुलिसकर्मियों के खिलाफ गैर इरादतन हत्या का मामला दर्ज किया गया है। मामले की जांच की जा रही है। गौरव के पिता मूलचंद्र शर्मा के आंसू थम नहीं रहे हैं। उन्होंने कहा, मेरी आंखों के सामने ही सब कुछ लुट गया और मैं कुछ ना कर सका।

## Building plan approval system to go online in 15 days

**GHAZIABAD:** The online building plan approval system will be in place across Uttar Pradesh in the next 15 days and once it becomes operational, no maps would be approved offline. Officials said applications for approval would have to be submitted online and junior engineers will have to inform the applicants about any objections within seven days of that date. After the stipulated time period, officials will not be able to raise any objections regarding the plan. A letter issued by Deepak Kumar, the principal secretary, housing and urban planning

department, stated that under a government order issued on June 20, 2019, authorities and parishads will have to give approvals to maps and layouts within 30 days of submission. "After an application is received and the required fee has been paid, officials at the junior engineer level are to inform applicants about all sorts of objections they might have within a maximum period of seven days. After that, no objection can be raised at any level. Offline approvals would be stopped immediately. Any violation will be taken seriously," the letter had stated.



## वसुंधरा में जनरेटर से बैटरी चोरी, घटना सीसीटीवी में कैद

वसुंधरा : वसुंधरा क्षेत्र में बदमाशों के हौसले दिन प्रतिदिन बढ़ते जा रहे हैं। शनिवार तड़के क्रेटा में आए तीन बदमाशों ने वसुंधरा सेक्टर-12 में घर के बाहर रखे जनरेटर से बैटरी चोरी कर ली। बदमाशों ने घटना को ढाई मिनट में अंजाम दिया और फरार हो गए। यह घटना सीसीटीवी में कैद हो गई है। वसुंधरा सेक्टर-12 स्थित फ्रैंड्स को-ऑपरेटिव सोसायटी के प्लैट नंबर-516 में समाजसेवी डॉ.धीरज भार्गव परिवार के साथ रहते हैं। सोसायटी के गेट नंबर-दो के पास ही घर के बाहर उन्होंने 25केवी का जनरेटर लगा रखा है। शनिवार दोपहर करीब 3 बजे जब वे जनरेटर चलाने पहुंचे तो देखा कि उसका ताला टूटा हुआ है और बैटरी गायब है। उन्होंने घर पर ही लगे सीसीटीवी कैमरे की फुटेज निकाली तो देखा कि शनिवार तड़के करीब 3.53 बजे क्रेटा से तीन बदमाश आए। इनमें से कंडक्टर साइड व पीछे से दो बदमाश उतरकर जनरेटर के पास पहुंचे और ताला तोड़कर मात्र 2.30 मिनट में ही बैटरी निकालकर कार में रखकर फरार हो गए। जबकि तीसरा बदमाश ड्राइवर सीट पर बैठा रहा। सीसीटीवी में यह घटना कैद होने पर उन्होंने पुलिस कंट्रोल रूम को चोरी की सूचना



दी। सूचना पर पहुंची पुलिस ने जांच पड़ताल की, लेकिन खबर लिखे जाने तक पुलिस

ने मुकदमा दर्ज नहीं किया था। पीड़ित डा.धीरज भार्गव का कहना है कि पुलिस रात्रि के

समय इस सर्विस रोड पर गश्त नहीं करती। जिससे यहां चोरी की घटना हो रही है। उन्होंने

पुलिस से जल्द ही चोरों को पकड़ने व सर्विस रोड पर पुलिस गश्त की मांग की।

## जब पार्षद ने प्रहलाद गढ़ी प्राथमिक विद्यालय की बिजली जुड़वाई

भेज रहा हैं। परिषदीय स्कूल में सौ यूनिट फिक्स है। इसकी जांच के लिए विद्युत निगम के उच्चाधिकारियों से बात कर बिजली चालू कराई जाएगी। इसके बाद भी बिजली न जुड़ने पर पार्षद अरविंद चौधरी ने सख्त रुख अख्तियार किया और बिजली विभाग, शिक्षा विभाग व विधायक को इस मामले से अवगत कराते हुए जल्द ही विद्यालय की बिजली

चालू कराने की चेतावनी दी। जिस पर विधायक सुनील शर्मा के हस्तक्षेप के बाद बिजली को जोड़ा गया। यदि इस मामले में पार्षद कुछ नहीं करते तो बच्चे गर्मी से बेहाल हो जाते। इस पर स्कूल के अध्यापक व बच्चों ने पार्षद का धन्यवाद दिया। पार्षद ने कहा कि जहां देश के प्रधानमंत्री व मुख्यमंत्री का नारा है बेटी बचाओ बेटी पढ़ाओ स्कूल चले हम का नारा दे रहे हैं वहीं विद्यालय की बिजली काटकर बच्चों को परेशान किया जा रहा है। जहां लाखों-करोड़ों रुपये की बिजली चोरी हो रही है वहां विद्युत विभाग कार्रवाई नहीं करता और यहां चंद पैसों के लिए सरकारी स्कूल की बिजली काट दी जाती है। जिसका हर्जाना बच्चों को झेलना पड़ता है।

## वाहनों के दस्तावेज डिजिटल लॉकर में रखें : आईजी जोन मेरठ

गाजियाबाद :वाहन चलाते समय अब लोगों को कागजात रखने से मुक्ति मिल जाएगी। गाजियाबाद पुलिस डिजिलॉकर और ऑनलाइन डॉक्यूमेंट्स को भी मान्य करेगी। इस बाबत आईजी जोन मेरठ आलोक सिंह ने निर्देश जारी किए हैं। निर्देश में सभी इलेक्ट्रानिक और डिजिटल कागजातों को मान्य करने की बात कही गई है। आईजी जोन मेरठ ने 19 नवंबर 2018 को सड़क परिवहन एवं राजमार्ग मंत्रालय से इलेक्ट्रानिक दस्तावेजों

को भी जांच के दौरान मान्य होने के संबंध में स्थानीय पुलिस को निर्देश जारी किए हैं। इसके तहत सभी वाहनों के रजिस्ट्रेशन, इंश्योरेंस, फिटनेस, परमिट, ड्राइविंग लाइसेंस की मूल कॉपी या इलेक्ट्रानिक कॉपी को डिजिलॉकर या एमपरिवहन एप पर दिखाने पर वैध प्रमाण माना जाएगा। इलेक्ट्रानिक कॉपी दिखाने पर किसी भी नागरिक को सुरक्षा अधिकारी द्वारा परेशान नहीं किया जाएगा।

## जुर्माना दोगुना होते ही नियम तोड़ने वाले हुए आधे

गाजियाबाद : हेलमेट व सीट बेल्ट ही लगाने पर दोगुना जुर्माना लगने से लोग अब ट्रैफिक नियमों का पालन करने को लेकर जागरूक हो रहे हैं। अगस्त और सितंबर माह के चालानों की संख्या में 47 फीसदी तक कमी आई है। वहीं प्रदूषण प्रमाणपत्र बनवाने वालों की संख्या भी दोगुनी हो गई है। केंद्र सरकार की ओर से ट्रैफिक नियमों के उल्लंघन पर जुर्माना शुल्क बढ़ाने के आदेश को जारी कर दिया है, लेकिन प्रदेश सरकार की ओर से इस

पर कोई आदेश नहीं जारी किया गया। जुर्माना शुल्क बढ़ने के डर से वाहन चालक भी अब ट्रैफिक नियमों का निरंतर पालन कर रहे हैं। इससे जनपद में होने वाले चालान में भी कमी आई है। पिछले माह की तुलना में सितंबर में लगभग आधे चालान कटे हैं। ट्रैफिक पुलिसकर्मियों ने भी बताया कि जिस मार्ग पर एक दिन में ट्रैफिक नियम उल्लंघन करने वाले 50 लोगों के चालान होते थे। वहां अब 20 से 30 लोगों के ही चालान

होते हैं। 95 फीसदी लोग अब दोपहिया वाहनों पर हेलमेट और कार में सीटबेल्ट पहन कर निकलते हैं। एक दिन में करीब 400 से 500 चालानों की संख्या में कमी आई है। वहीं एक हजार रुपये के चालान के डर से हेलमेट की दुकानों पर बिक्री बढ़ गई है। दिन भर हेलमेट खरीदने वाले चालकों की कतारें लगी रहती हैं। मेरठ रोड पर मुरादनगर और दुहाई स्थित दुकानों पर एक दिन में 100-150 हेलमेट की बिक्री हो रही है।

## A weak chase: On controlling hepatitis B

**Bangladesh**, Bhutan, Nepal and Thailand became the first four countries in the World Health Organization's southeast Asia region to have successfully controlled hepatitis B. The virus is said to be controlled when the disease prevalence is reduced to less than 1% among children less than five years of age. Despite the introduction of hepatitis B vaccine in the Universal Immunisation Programme in 2002 and scaling-up nationwide in 2011, about one million people in India become chronically infected with the virus every year. According to the Health Ministry, as on February 2019, an estimated 40 million people in India were infected. Hepatitis B infection at a young age turns chronic, causing over 1,00,000 premature deaths annually from liver cirrhosis or liver cancer. A study published in 2013 found lower coverage of hepatitis B vaccine in eight of the 10 districts surveyed. But the coverage has witnessed an increase with the introduction of a pentavalent vaccine on a pilot basis in Kerala and Tamil Nadu in December 2011 and national roll-out in 2014-2015. According to the WHO, the coverage of hepatitis B third dose had reached 86% in 2015. However, despite the high vaccination coverage, disease prevalence in children aged less than five years has not dropped below 1%. One of the reasons for this is the sub-optimal coverage of birth dose in all infants within 24 hours of birth.

Hepatitis B birth dose, given in the first 24 hours, helps prevent vertical transmission from the mother to child. The compulsion to increase birth dose to cut vertical transmission arises from two important reasons about 70-90% newborns infected this way become chronic carriers of hepatitis B, and about 20-30% carriers in India are due to vertical transmission. But even seven years after the Health Ministry approved the birth dose in 2008, its coverage remained low 45% in 2015 and 60% in 2016 according to a 2019 Health Ministry report. What is indeed puzzling is that even in the case of institutional delivery, the birth dose vaccine coverage is low 76.36% in 2017. Incidentally, institutional delivery accounts for about 80% of all deliveries in the country. The birth dose coverage when delivery takes place outside health-care institutions is not known. One of the reasons for the low coverage is the fear of wastage of vaccine when a 10-dose vial is used. Unfortunately, health-care workers are very often unaware of the WHO recommendation that allows hepatitis B open-vial policy. Opened vials of hepatitis B vaccine can be kept for a maximum duration of 28 days for use in other children if the vaccine meets certain conditions. There is also a need to increase public awareness about the merits of the birth dose.

### Bank executive found dead in Noida PG facility

**NOIDA:** The body of a field executive working at the Barclays' office in Sector 62 was found in a paying guest facility in the city on Friday. Vivek Arora (28) was a resident of Delhi's Shastri Nagar. At least 10 injections and needles were found next to his body, leading to cops suspecting a drug overdose. The room itself was in a mess. According to cops, Vivek had rented the room in the PG around 10.30 pm on Wednesday. Sub-inspector Vinod Yadav told TBC that on Thursday evening, Vivek apparently told Chandan, the manager of the PG in Sector 46, to wake him up around 7am the next day.

### 'Auto gang' robs woman of cash, mobile

**GHAZIABAD:** A 40-year-old woman was allegedly robbed of cash worth Rs 2,000 and her mobile phone by an 'auto gang' in Sihani Gate area on Saturday. The victim, Rakhi Singh, lives in Nehru Nagar 2. Around 9 am on Saturday, she sat in a shared auto near Old Bus St-and to go to a clinic in Noida for treatment. Singh told police the auto had a driver and three other men posing as regular passengers. After driving for a distance, the driver stopped as the person sitting next to him insisted on sitting in the rear. The driver also agreed with him saying the police will issue a challan if they find someone sitting on the front seat, the woman alleged. Singh, meanwhile,

protested saying there was no space for a fourth person at the back. While she was speaking to the driver, a passenger at the back opened her purse. She asked the driver to let her get down, but he started the vehicle. Singh was pushed her out of the moving auto and sustained injuries. She raised an alarm but no one came to her rescue. She even caught hold of the vehicle and was dragged for some distance. She finally let go of the vehicle when the driver increased the speed. The mobile phone and cash kept in the purse were later found to be missing. Based on her complaint, an FIR for theft was registered against unidentified persons at Sihani gate police station.

### Plan to streamline traffic, decongest Pari Chowk to be rolled out next week

**NOIDA:** The Pari Chowk decongestion plan, which will be implemented from September 15, will include a new 'green' bus stop and shifting of most buses, cabs and auto-rickshaws parked at the intersection to the adjoining metro stations for temporary halts. Officials said the decongestion plan will relieve at least 60-70% of the traffic pressure immediately. "We have discussed the solutions with all stakeholders from the authority, administration and traffic police, and all have approved it. We have been told that we don't need to make structural changes involving high cost or widen the roads.

### Guard carrying school bag thrashed over child-lifting rumours

**GHAZIABAD:** A 50-year-old guard with EDM mall returning home from work was beaten up by a mob on suspicion of being a child-lifter in Khoda Colony on Monday evening. A total of 16 persons were arrested. The victim Anuranjan Singh is a resident of Prem Vihar and os a security guard with EDM mall in Kaushambi area for several years. Sandeep Singh, the SHO of Khoda police station, said the guard was returning home after work when a group of youths suspected him to be

a child-lifter because he was carrying a school bag on his shoulders. "He had a school bag on the shoulders. Seeing that, people thought he was a child-lifter and beat him up," he added. A group of youths passing by stopped Singh and asked him what he was carrying in the bag. They started beating him up. Singh suffered injuries in the right leg and shoulders. The mob kept beating Singh and dragged him to Khoda police station. When the bag was opened at the police station, four chapatis and

some curry was found in a tiffin box. "The victim told police that when he was being beaten up by the mob, he tried to tell them he is a security guard. But nobody listened to him," the SHO said. An FIR has been registered against the arrested accused along with some unknown persons under sections 147 (punishment for rioting), 323 (punishment for voluntarily causing hurt) and 500 (punishment for defamation) of the IPC. The accused will be presented in court on Tuesday.

### Friends beat 24-year-old Mathura man to death in Noida

**AGRA:** A 24-year-old man, who hailed from Mathura's Nera village, was allegedly beaten to death by a group of youths in Noida, where the former worked in a private firm. The cause of clash was not immediately known as the man was staying alone in a rented accommodation. A case has been registered under section 302 (murder) of the IPC against two identified and several unidentified people at Phase II police station of Noida. Singh said that Amit was working in a company called Karvy. Amit's elder brother, Ajeet, had also gone to Noida to meet his brother.

### Flaws found in steps to tackle crashes on expressway

**NOIDA:** A team from the Yamuna Expressway Industrial Development Authority (YEIDA) inspected changes made by Jaypee Infratech to ensure safety of travellers on the 165km Yamuna Expressway and asked the concessionaire to install crash barriers at the earliest. On July 8, a speeding bus had fallen into a drain from one such point near Agra, killing 29 people and injuring at least 25 others. Following the accident, YEIDA had asked Jaypee Infratech to submit an action plan regarding road safety measures that could reduce the chances of accidents. YEIDA officials said

the concessionaire had agreed to put in place five road safety measures within a month. "We checked the entire stretch from Greater Noida Zero Point to Agra and found some shortcomings. The crash barriers are only installed from Zero Point up to 38km and at some places towards Agra. The entire stretch needs to be covered on a priority. We have asked the concessionaire to install cat eyes within 15 days," said Arunvir Singh, CEO of YEIDA. Ajit Kumar of Jaypee Infratech said, "Crash barriers are being installed and the entire work will be completed by this month."



## Cop stops SUV on wrong side, thrashed

**GHAZIABAD:** A 23-year-old man driving his SUV on the wrong side allegedly beat up a traffic police constable who tried to stop him near a roundabout in Sihani Gate area on Saturday. Tarun Tyagi, a college student and resident of Patel Nagar III, was arrested on Sunday. According to a complaint by constable Pradeep Kumar, the cop was on duty at Seth Mukund Lal Inter-College crossing on Hapur Road when he saw a Fortuner coming from the wrong direction around 2.30pm. He signalled the driver to stop the vehicle, but instead, he tried to hit the cop

with the car. Kumar said he jumped aside to save himself. Tarun and three-four of his friends got down from the vehicle and allegedly abused him. When the constable objected to their behaviour, they allegedly thrashed him, tore his uniform and also tried to throttle him before fleeing. The FIR was subsequently registered against Tarun and his unidentified accomplices under IPC sections 332 (voluntarily causing hurt to deter public servant from his duty), 353 and 504 (intentional insult with intent to provoke breach of the peace) at Sihani Gate police station.

## Electrocution: Firm’s owner, 2 others booked

**Noida:** Almost a month after a 27-year-old engineer was electrocuted while working at a factory in Noida’s Sector 11, the owner of the company and two other senior officials have been booked under the charge of causing death due to negligence. An FIR has been lodged following a complaint by the elder brother of Ankit Mishra, alleging that the engineer was forced to repair a moulding machine installed in the factory of S K Enterprises. Ankit’s family alleged that he had not been given any safety equipment before opening the machine, and 440V of current passed through him.

**GHAZIABAD:** Aiming to provide relief to scores of people who have been duped by land mafia, the district administration has devised a seven-step process to resolve such cases. District magistrate Ajay Shankar Pandey said from September 21, complainants can obtain the application form from the tehsil office free of cost. The complaint will then be scrutinised by sub-registrar office and tehsildar. In subsequent steps, it will be investigated by the sub-divisional magistrate, police and finally by the additional district magistrate. A software

## Mobile snatcher bludgeoned to death

**NOIDA:** Four men were arrested on Friday evening for allegedly bludgeoning a 25-year-old mobile phone snatcher to death near FNG Road in Phase 3 on September 5 while he tried to rob them. The arrested men, Fateh Singh, his brother Gaurav and two accomplices, Prem Kumar and Sandeep Tiwari, are from Bulandshahr. The mobile phone snatcher, Amit, used to stay in Mamura with his brother. Police said he was employed with a private firm, but had connections with a gang that robbed people.

## Nandi Park’s bulls double in six months

**GHAZIABAD:** The number of bulls and oxen has nearly doubled at Nandi Park in the last six months after UP chief minister Yogi Adityanath issued a diktat in January that stray cattle should be shifted to shelter homes. Spread over 15 acres of land, Nandi Park, India’s first cattle shed for bulls and oxen, was set up in 2009 in Raj Nagar Extension. Officials said after the CM’s order, residents — not only from Ghaziabad but also from neighbouring Delhi — have been abandoning cows, bulls and a large number of calves at the shed’s gate and near the Delhi-Ghaziabad border

at night. The shed, which had 500-600 bulls and oxen at the beginning of the year, now has about 1,150. It has a capacity of 1,500. However, the amount fixed by the state government to feed the bulls and oxen at the centre is meagre, adding to the woes of the cash-strapped Ghaziabad Municipal Corporation (GMC). “The daily budget is Rs 30 per animal, which is less than half of the amount required to feed a bull or ox. At least 6 kg of straw and 3 kg of bran, besides green fodder, are needed to feed a bull every day, and altogether it costs around Rs 80.

is also being developed for receiving cases related to land disputes online, the DM added. “Being next to the national capital, land in Ghaziabad remains in high demand. The land mafia takes advantage of this and dupes unsuspecting buyers. People from all sections of society are victims of this scam. In several cases, buyers are duped by the land mafia in connivance with government officials,” Pandey said. He

said the main focus is Loni, where the land mafia has been most active. “We have been working in this area for the past one and a half months and found that land mafia has sold a single plot of land to several people and registered plots to people with forged power of attorney. There have been cases where government land has been occupied and sold,” the DM said. Scores of complaints are being registered every day with the chief minister’s portal, Integrated Grievance Redressal System (IGRS), as well as during tehsil divas and jan sunwais, Pandey said.

## Relief plan for nine congested Noida spots

**NOIDA:** The Noida Authority has identified nine congested stretches across the city for which road improvement measures will be taken immediately. A comprehensive mobility plan (CMP) will also be prepared for traffic management in the city. Officials said several agencies have been identified and have been asked to submit a proposal for preparing the CMP. The agency will study the requirements for the entire city to prepare the CMP for which about nine months’ time would be given,” said P K Garg, senior manager, Noida Authority.

## Cops stop ‘dairy’ truck on EPE, find liquor cartons in it

**NOIDA:** Police on Sunday seized 100 boxes containing liquor bottles of Crazy Romeo and High Time that were being transported via the Eastern Peripheral Expressway (EPE) in a truck which had the words “Mother Dairy” painted on the front and rear. The driver of the truck has been arrested on the suspicion of smuggling liquor. Police said he had deliberately written Mother Dairy on the truck to avoid being detected. The cops are verifying if the truck was also used to transport milk products. Police said the consignment of liquor was

worth about Rs 2.5 lakh and the stickers pasted on the bottles stated they were for sale in Arunachal Pradesh. Dinesh Singh, the SHO of Dadri police station, said the truck, which was travelling from Haryana towards Meerut, was caught near Bil Akbarpur village on the EPE. “The truck — UP 15ET3778 — was being driven by one Amit, a resident of Hapur. He has admitted to supplying liquor illegally in Meerut and Hapur. We are verifying his criminal history. So far, it does not seem he has a criminal record,” Singh said.

## Noida: 19-year-old held for killing Lucknow gas agency's cashier

**NOIDA:** A 19-year-old man who allegedly shot dead the cashier of a gas agency in Lucknow last year was arrested from Greater Noida by the Uttar Pradesh Police's Special Task Force (STF), officials said on Saturday. The accused, Anoop Singh alias Annu, is a member of the nomadic Bawaria gang and was arrested from Ecotech 1 area late on Friday night by the Noida unit of the STF, they said. "We had got a tip-off yesterday (Friday) about Anoop's movement in Greater Noida where he was aiming for another robbery.

## Minors in robbery bid at MLA house

**NOIDA:** At least two juveniles entered a house in Sector 11, belonging to a BSP MLA from Rajasthan, and tried to flee with three metal statues on Saturday night, police said. While one of them was caught by the servant working in the house, the other managed to flee. Apart from the duo, police are questioning two other seven-year-old boys in connection with the incident. The incident happened around 8.30 pm on Saturday, when MLA Joginder Awana’s family members were in the hospital due to his wife’s ongoing treatment. “My wife is in the hospital and my family was attending her. Around 9 pm, I

got a call from my servant saying that he had caught a 14-year-old boy, who was trying to flee with the metal statues kept in our drawing room,” he said. Awana told TBC that the boys had entered the house when his servant Pappu had gone to the nearby market. Pappu said that he saw the boy near the doorstep when he returned. “After he saw me, he hit my hand with a metal statue and fled. He left the statues there itself. However, when I went out, I saw another boy standing at a distance. He tried to flee from the lane behind the house but a neighbor helped me in catching him,” he said.



## Jail, bail and jail: Ghaziabad serial con artist back behind bars

**GURUGRAM:** A 27-year-old Ghaziabad resident, out on bail after he was arrested last month in Noida for posing as a PMO official, landed in prison again on Friday, this time in Gurugram where he had cheated a former colleague by impersonating a police officer. Gaurav Mishra was arrested last month in Noida because he had calling government officials posing as an IPS officer, a PMO official, the husband of an IAS officer and even a friend of a senior BJP functionary. He was using these fake identities to put pressure on these government officials to carry out transfers

and postings for his anonymous clients. He has been in the police files since 2012 when he was caught influencing admissions to a private university using the same modus operandi. Mishra is from Allahabad. Police in Gurugram were looking for Mishra in their probe into a case filed by Lokesh Sharma, a resident of Sector 84. Sharma claimed he had got a call from Mishra, a former colleague, on Diwali 2014. Mishra told him over phone that after quitting the job at Sunil Auto in Uttarakhand where the two used to work together, he prepared for the

civil service exam and became an IPS officer in 2012. He also claimed he was posted at the NIA headquarters in Delhi and was married to an IAS officer from his batch, Aniketa. “He made me talk to his wife over phone and she also verified his claims,” Sharma said in his complaint. But all of this was fabricated. “I kept receiving calls from Gaurav Mishra. On two occasions, he visited my house along with one R K Sharma who was wearing a police uniform and carrying his ‘service revolver’,” said Sharma, adding they also met at a pub on MG Road and Mishra tried to influence the

pub owners by flaunting his identity. Soon, Mishra introduced him to a property dealer who claimed to be developing a residential project, ‘Golf Link’, in Greater Noida. Mishra claimed his wife and brother-in-law Ashutosh Rathi were partners in the project and offered to help Sharma get a 100 square yard plot for Rs 15 lakh. Sharma agreed and it was decided that he will pay Rs 9 lakh upfront and remaining Rs 8 lakh will be paid at the time of registry. By November 2015, he made the full payment and was assured that the plot will be registered in his name in no time.

## Woman stages son’s kidnap, held with lover

**GHAZIABAD:** A woman has been arrested for allegedly staging the kidnap of her five-year-old son so that she could elope with her lover. Three others, including the woman’s lover and a friend with whom she had kept the child, have been arrested from Khoda area. The accused have been identified as Zenab, mother of the boy, her friend Komal, lover Salman and Komal’s mother-in law, Sunita. Police said preliminary investigations showed that Zenab had kept her son with Komal so that she could tell her husband that their son had been kidnapped by a



child-lifter. Earlier too, Zenab had told her husband she wanted to marry Salman, but the husband had sought time for divorce as their son was growing up. By staging the kidnap of the child, Zenab allegedly planned to tell her husband Shahrugh that now that their son was no longer with them, he should give her divorce.

## Gulmohar residents allege mismanagement by builder

**GHAZIABAD:** The residents of Gulmohar Garden Society in Raj Nagar Extension have accused the developer for mismanagement with regards to providing basic facilities, like water and power supply, and refusal to hand over the society’s maintenance to the Apartment Owners Association (AOA). Ghaziabad Development Authority (GDA) on Wednesday issued a notice to SVP Builders and asked it to start the process of handing over the society’s maintenance to the AOA immediately. The letter said that a builder-buyer

meeting was held on August 8 and there, the developer was asked to resolve all pending issues. But no initiative has been taken on the ground. “We have been getting constant complaints about erratic power and water supply, besides poor maintenance of lifts. The residents are facing a lot of problems,” the letter said. On Sunday, several residents had staged a protest at Sihani Gate police station against the developer after the management body allegedly shut down power and water supply, following an argument with the maintenance staff.

## Robbers target Army truck with Rs 250cr chopper parts

**GHAZIABAD:** Three men were arrested early on Monday for allegedly robbing the driver and helper of an Army truck that was carrying helicopter parts worth Rs 250 crore on Saturday. Police said the arrested men did not know about the consignment that was being carried to Imphal from Delhi cantonment. The parts of the helicopters, deployed in border areas, had been sent to Delhi for an inspection. Police said the truck had left Delhi cantonment around 11pm on Friday. “An army personnel, Vishal, and a different driver were assigned the duty to accompany the vehicle, but

they handed over the truck to driver Atul and helper Anil somewhere in Delhi and Vishal had asked them to pick him up from his house on the way,” said SSP Sudhir Kumar Singh. Around 1.30am when the truck reached near New Bus Stand in Ghaziabad, a Swift car came from the back side and intercepted the vehicle. Some men came out of the car and snatched Rs 20,000 cash and ATM cards from Atul and Anil at gunpoint. Another helper, Ashok, managed to escape. Police said the robbers held the duo hostage and beat them up with the butt of the gun. They also burnt their hands and

other body parts with cigarettes in order to know the pin number of the ATM cards. According to the SSP, the accused tried to withdraw money from an ATM in Raj Nagar Extension using the victims’ ATM cards, however, they failed. They then dumped the duo around 7.5 km away from Raj Nagar Extension and fled. The duo then informed the army personnel at the Delhi cantonment and then filed a complaint at Sihani Gate police station. The three arrested men Sonu Prajapati, Sonu Tyagi and Praveen Das, all belong to Ghaziabad. While Tyagi is a high-school pass,

the other two have failed Class VI. Singh told TBC that Sonu Prajapati’s father had bought a second hand swift car around a year ago. On the basis of the car’s registration number, the first owner of the car was traced in Haryana who told police that he had sold it to one Rakesh Prajapati. Police on Saturday detained Rakesh who revealed that his son had taken the car on the day the robbery was conducted and did not return home after that. Later, a police team nabbed Sonu Prajapati and Praveen from Sihani Gate and early on Monday Tyagi was also arrested from his residence.

## Trio kill man with stone, arrested

**GHAZIABAD:** Three persons have been arrested for allegedly killing a 38-year-old man with a stone after he objected to their presence in front of his house in Tronica City on Thursday night. Police had found the body of Arun Tyagi on a secluded plot in Loni on Friday morning. The accused Ankit, Gaurav Khari and Peeyush are from Tronica City. On Thursday, they were fighting with Tyagi’s tenant outside his house when Tyagi asked them to leave. After they refused to do so, Tyagi and a few neighbours threw them out. SP (rural) Neeraj Kumar Jadaun said Tyagi had abused the trio in front of other people

and they felt humiliated. On the same night, the accused had been drinking in a park when they planned to take revenge. “They had abducted Arun Tyagi from his house and taken him to a vacant plot. There, they beat him up and burnt his hands with cigarettes stubs. Arun Tyagi had slapped one of the accused in rage and tried to flee. But the accused picked up a heavy stone and hit Arun Tyagi several times in the head, killing him on the spot,” Jadaun added. The accused were arrested under Section 302 (murder) and they sent to Dasna jail after being produced in court.

## Shots fired after feud in college, two students hurt

**GHAZIABAD:** A fight between two groups of students at MM degree college in Ghaziabad’s Modinagar took a terrifying turn when one amongst them fired gunshots, injuring two students on Tuesday. Police said that both the victims were admitted to a nearby hospital and are in a stable condition. At 11.30 am, Sumit (20), a resident of Nand Nagri, and Kapil alias Nikhil (19) from Meerut, were on the way to their classroom after parking their vehicles when the crime took place, police said.

## Three arrested for illegal mining in Ghaziabad

**GHAZIABAD:** Three persons were booked on Tuesday for their alleged involvement in illegal sand mining in Tronica City. Ghaziabad district magistrate Ajay Shankar Pandey has also constituted a committee under the additional district magistrate (administration) Jitendra Sharma to investigate the role of local police, Uttar Pradesh State Industrial Development Corporation (UPSIDC) officials and the owner of a private firm in the illegal mining, and submit a report on the same

within a week. The arrested persons have been identified as Manoj Sharma and Mahendra, both residents of Aligarh, and a pokland machine driver Ashok. Police said the three persons were booked under relevant sections of the acts related to mines and mineral resources, besides Prevention of Damage to Property Act. “Illegal mining will not be allowed in the district. The role of local police, UPSIDC officials and a private firm is found to suspicious, so an inquiry is being conducted by the ADM.

## Noida Authority carries out sanitation drive

**NOIDA:** Noida Authority carried out designated safaigiri (sanitation) drive across sectors 11, 19, 52 and 82 where residents were apprised on sanitation measures including keeping their environments clean, saying no to plastic and ensuring segregated waste disposal. While residents joined authority officials in cleaning their sectors, local sewer and drain problems were addressed on spot. Residents were also administered the Swachhta oath by officials who were accompanied by members of AG Enviro Pvt Ltd, the agency dealing with door-to-door waste collection in the city and Adarsh Sewa Samiti.

## 22 Crossings societies don’t have completion certificates

**Ghaziabad:** Twenty two out of 31 group housing societies in Crossings Republik are yet to get completion certificates from the Ghaziabad Development Authority (GDA). The agency has issued notices to builders warning it would cancel their map approvals if they do not apply for the certificate within a month. The notice states that it is against the rules to hand over flats to residents in the absence of completion certificates. Sushil Kumar Chaubey, GDA officer on special duty, said, “In case the builders do not respond to our notice, action will be taken against them under relevant sections of the Uttar Pradesh



Urban Planning and Development Act.” According to a GDA report, out of 31 group societies in Crossings Republik, 24 have formed the Apartment Owners’ Association (AOA), but only two have been handed over the maintenance by the builders. The developers have also been directed to help in the formation of the AOAs. Under the UP Urban Planning and Development Act, builders are required to complete the

development according to the approved plan and obtain a completion certificate from the authority to show that they have not violated any rules or diverted from the layout approved by GDA. Before applying for the completion certificate, the developers have to ensure that proper space for road construction and green belt has been made in accordance with the master plan. The builders also have to obtain no-objection certificates from the fire department, electricity department, UP Pollution Control Board for the fire safety arrangements, lifts and environmental clearance, respectively.

## Noida Authority to begin 'plastic free' drive from September 11 to October 1

Under the drive, the authority will engage in sanitation and cleanliness awareness measures across residential sectors and villages of the city and ensure a clean Noida.

## Delhi has cheapest power in NCR; tariff lower than even Mumbai

**NEW DELHI:** Delhi has the cheapest power rates among the NCR cities and even less than Mumbai, the AAP government said on Wednesday. According to a government spokesperson, immediately after assuming office in February 2015, chief minister Arvind Kejriwal had directed that Delhiites should get uninterrupted power supply 24x7 at the lowest electricity rates in India. “Almost four and a half years later, the Kejriwal government proudly states that the promise has been fulfilled, which is evident from the comparison of electricity rates of Delhi with that of Gautam

Budh Nagar (Noida), Ghaziabad, Gurugram — all NCR towns — and also that of Mumbai,” he said, adding that only yesterday it was announced that electricity tariffs in Uttar Pradesh will be increased by 12%. “Tariffs in Delhi used to follow a ritualistic year-on-year rise for many years till 2014-15. The expenses shown by the discoms to DERC would determine the tariffs of the customers. The gap between the expenses shown by the discoms and the revenue recovered from Delhi’s consumers would accumulate as Regulatory Assets (RAs).”

## Khoda’s civic issues to be heard twice every week

**GHAZIABAD:** The district administration has deputed a magistrate to deal with civic issues in Khoda, one of Asia’s largest colony of migrant workers, and Makanpur, which is on the other side of NH9. The officer will sit in the Khoda-Makanpur nagar palika parishad office twice a week and listen to residents’ grievances. District magistrate Ajay Shankar Pandey said the magistrate would take note of the basic issues such as water, drainage and encroachment and follow them with the nagar palika on how they can be addressed.

## Drunk man shoots wife in UP's Loni

**GHAZIABAD:** A property dealer was arrested for allegedly shooting his 30-year-old wife over an argument at Loni in UP's Ghaziabad district early on Wednesday. The accused, Adesh Bhati, is a resident of Ram Vihar Colony. Police said the deceased was Bhati’s second wife and they used to frequently fight over financial issues. Around 1.30am, Bhati rang the police control room and alleged that his wife Anita had been shot at by two unknown persons when she opened the door of the house. A police team reached his house and found that the woman was breathing. She was immediately rushed to

GTB hospital where she succumbed to her injury. SP (rural) Neeraj Kumar Jadaun said, “Police found the role of Bhati suspicious and questioned him extensively. He changed his statements several times during questioning, but finally almost after four hours, he confessed to committing the crime.” Bhati told police that Anita was his second wife whom he had married in a court in 2010. His first wife lives in Tila Ambedkar Colony with his three kids. He had no kids with Anita. He also informed cops that he had been suffering losses in the business and also had a loan of around Rs 80 lakh on his head.

जांच के लिए पहुंचे। यहां पर केन्द्र चालक ने डीजल वाहनों के लिए प्रमाणपत्र जारी करने से मना कर दिया। उनका कहना था कि डीजल वाहनों के लिए ऑनलाइन बनता है, जो अपडेट नहीं है। इसके बाद योगेश त्यागी अर्थला में पेट्रोल पंप पर प्रदूषण केन्द्र पर जांच करने पहुंचे। वहां पर केन्द्र संचालक ने डीजल वाहन का प्रमाण पत्र जारी करने से मना कर दिया। उन्होंने वजह पूछी तो बताया गया कि डीजल वाहनों का शहर में कोई नहीं कर रहा है।
